8.1 Lord Mayor Reynolds - Removal of Press Buttons on Pedestrian Crossings in the CBD

Question: Can we ask the State Government to permanently remove

the need to press pedestrian light buttons in the CBD, which is currently a temporary measure and also extend the area to include lights along Morrison Street and the length of Elizabeth Street given its high pedestrian numbers?
