A petition from Ridgeway residents regarding council planning decisions and the Rural Living Zone provisions of the planning scheme.

Dear Councillor Burnett,

Thanks very much for making the time to meet with us last week to discuss this petition from Ridgeway residents around the council planning decisions and the Rural Living Zone provisions of the planning scheme.

To summarise the points that we discussed last week:

- Ridgeway is a unique suburb of Hobart with rural, village-like characteristics, open paddock space, treed landscapes, and a strong community feel.
- This petition arose out of community concern that the rural values of Ridgeway are being eroded.
- When a representation was made to the Council Planning Committee in March 2019 about a planning decision affecting Ridgeway, Cllr Burnet stated that if the residents of Ridgeway were not happy with planning decisions in their area, that they should represent to Council
- This petition acts on that invitation to represent to Council.
- Our conversations with residents uncovered very strong community support for maintaining the rural values of Ridgeway, including maintaining space and separation between houses, maintaining existing paddocks, and treed landscapes, not building right up to property boundaries, and not wishing Ridgeway to become suburbanised.
- Our conversations with residents uncovered dismay at recent developments, including a house currently being built in what was previously the paddock space that is characteristic of Ridgeway, at 58 Hall St. Many residents referred to this as "infill housing" and stated that they did not want to see this kind of development in Ridgeway. Many residents stated that they "couldn't believe" that the Council had allowed this development.
- This petition calls for future Council planning decisions to better adhere to the provisions of the Rural Living Zone section of the planning scheme, particularly the sections of the scheme that appear in the petition text.

We very much appreciate the interest you have taken in this matter and look forward to further constructive conversation with you, and meaningful action from the Council.

We look forward to hearing from you on possible next steps the Council may take to respond.




