









Pursuant to the *Hobart Interim Planning Scheme 2015*, the Council approve the application for fencing at 11 Waterworks Road, Dynnyrne and a permit containing the following conditions be issued:

GEN

The use and/or development must be substantially in accordance with the documents and drawings that comprise PLN-17-166 - 11 WATERWORKS ROAD DYNNYRNE TAS 7005 - Final Planning Documents except where modified below.

Reason for condition

To clarify the scope of the permit.

ENG 1

The cost of repair of any damage to the Council infrastructure resulting from the implementation of this permit, must be met by the owners within 30 days of the completion of the development or as otherwise determined by the Council.

A photographic record of the Council infrastructure adjacent to the subject site must be provided to the Council prior to any commencement of works.

A photographic record of the Council's infrastructure (e.g. existing property service connection points, roads, buildings, stormwater, footpaths, driveway

crossovers and nature strips, including if any, pre existing damage) will be relied upon to establish the extent of damage caused to the Council's infrastructure during construction. In the event that the owner/developer fails to provide to the Council a photographic record of the Council's infrastructure, then any damage to the Council infrastructure found on completion of works will be deemed to be the responsibility of the owner.

Reason for condition

To ensure that any of the Council infrastructure and/or site-related service connections affected by the proposal will be altered and/or reinstated at the owner's full cost.

ENV 1

Sediment and erosion control measures sufficient to prevent sediment from leaving the site must be installed prior to any disturbance of the site. Sediment controls must be maintained until all areas of disturbance have been stabilized or re-vegetated.

Reason for condition

To avoid the sedimentation of roads, drains, natural watercourses, Council land that could be caused by erosion and runoff from the development, and to comply with relevant State legislation.

Ref: Open <u>CPC 7.1.4</u>, 15/05/2017 Application Expiry Date: 24 May 2017 Extension of Time: Not applicable

Pursuant to the *Hobart Interim Planning Scheme 2015*, the Council refuse the application for multiple dwellings at 3-4 Montgomery Court, Sandy Bay for the following reasons:

- The proposal does not meet the acceptable solutions or the performance criteria with respect to clause 11.4.1 of the Hobart Interim Planning Scheme 2015 in that the proposal does not contribute to a range of dwelling types and sizes appropriate to the locality.
- 2. The proposal does not meet the acceptable solutions or the performance criteria with respect to clause 11.4.2 P3 of the Hobart Interim Planning Scheme 2015 in that the siting and scale of the proposal causes an unreasonable loss of amenity by:
 - (i). Resulting in a reduction in sunlight to a habitable room (other than a bedroom) of a dwelling on an adjoining lot;
 - (ii). Resulting in overshadowing of the private open space of a dwelling on an adjoining lot;
 - (iii). Resulting in visual impacts caused by the apparent scale, bulk or proportions of the dwelling when viewed from an adjoining lot;
 - (iv). Not providing separation between dwellings on adjoining lots that is compatible with that prevailing in the surrounding area.
- 3. The proposal does not meet the acceptable solutions or the performance criteria with respect to clauses 11.4.3 P1 and P2 of the Hobart Interim Planning Scheme 2015 in that the dwellings will not have private open spaces that:
 - Are of a size and dimensions that are appropriate for the size of the dwellings;
 - (ii). Are able to accommodate outdoor recreational space consistent with the projected requirements of the occupants and operational needs, such as clothes drying and storage;
 - (iii) Incorporate reasonable space for the planting of gardens and landscaping;
 - (iv). Include areas that are capable of serving as an extension of the dwelling for outdoor relaxation, dining, entertaining and children's play that are conveniently located in relation to a living area of the dwelling and orientated to take advantage of sunlight.

Dr Anton Kriz

Transforming Your Place in the 21st Century: Regional Innovation Management by Design Session Sponsor – CT Management Group

Discover the lessons being learnt in Tasmania, Australia and from around the world about leading transformational change in regions. One of the keys is to highlight what individual places and regions can do to build suitable talent and champions to master this journey. Leadership is critical, as is knowing your purpose, and this needs to be strategically developed from both both both procession of top-down. In many ways, running regions is similar to running organisations. High performing regions are not simply endowed with the best resources but are deliberate about designing and implementing a positive trajectory. Dr Anton Kriz is the Program Convenor and Senior Lecturer for the Newcastle Business School, based at the University of Newcastle. Anton has gained insight in areas like China, with notable invitations from industry to participate in the last two Prime Minister missions. Anton recently chaired special sessions at Cambridge University for Research and Development Management on global cluster development. His critical work on Tourism Australia's 2020 China Strategy and current efforts in building innovation management capabilities in Northern Tasmania are highlights, with measurable multi-billion dollar impacts

An Unconforming Model for Community Change

Why change? Why challenge? Why try something different? Because we do not conform - we cannot afford to. Some years ago, the Queenstown community identified arts and culture as the best way to confront local challenges. With this mandate, a biennial arts festival, The Unconformity, was developed, providing a new, creative voice for one of the most provocative and inspiring regions of Australia. Travis Tiddy will share a vision for how imagination, boldness and belief in the transformative power of the arts can inspire social and economic change.

Travis Tiddy is a fifth-generation west coast Tasmanian who intimately understands the needs and challenges of regional Tasmania. Travis is the Founder and Director of the award-winning arts festival, The Unconformity, which embraces site-specific contemporary arts activity to enrich the lives of west coast people. Travis is Deputy Chair of Tasmanian Regional Arts; a member of the Contemporary Art Tasmania program committee; and a former board member of Ten Days on the Island. In 2014, Travis became the recipient of the Premier's Young Achiever in Tourism Award and in 2010, he received a Churchill Fellowship to conduct overseas research into community development concepts for postindustrial regions.



Dr Greg Moore

Urban Trees and Sustainable and Liveable Communities Session Sponsor - Dial Before You Dig

The aesthetic value of trees in Australian cities is widely appreciated but their economic significance is under-valued. Trees provide services, perform functional roles in cities and have a real economic value. An urban forest of 100,000 trees can save \$1.5 million per annum because their shade reduces electricity consumption and saves water. Shade can prolong the life of tarmac and reduce heatwave related deaths. An urban forest can improve human health outcomes by fostering a 1-2% increase in passive or active recreation that could save millions of dollars. And at a time of climate change, the value of urban trees cannot be under-estimated.

Dr Greg Moore was a Senior Research Associate at the University of Melbourne's Burnley College from 1988-2007 and Head of Resource Management from 2002-2007. Greg was the inaugural President of the International Society of Arboriculture, Australian Chapter, a member of the National Trust's Register of Significant Trees since 1988, served the Board of Greening Australia (Vic) for 20 years and has chaired Treenet since 2005. He is on the Board of Sustainable Gardening Australia and is a trustee of the Trust for Nature. Greg has also written four books and published over 160 scientific papers and articles

The General Manager reports:

"The attached program is provided to enable Aldermanic nominations to be sought for attendance at the Eco City World Summit, to be held in Melbourne from 12 to 14 July 2017.
