# REPORT TITLE: TASMANIAN WRITERS' CENTRE - REQUEST FOR SUPPORT

# **REPORT PROVIDED BY:** Acting Associate Director Community Development

# 1. Report Purpose and Community Benefit

- 1.1. The purpose of this report is to seek the Council's approval for the lease of office space on the fourth floor of the Hobart Council Centre to the Tasmanian Writers' Centre for a period of 12 months at a nominal rent.
- 1.2. This report also responds to a Question Without Notice by the Deputy Lord Mayor, Alderman Dr Peter Sexton at the Community, Culture and Events Committee of 11 April 2018, requesting that the General Manager provide advice on options available to assist the Tasmanian Writers' Centre in light of their funding shortfall.
  - 1.2.1. The Tasmanian Writers' Centre (the TWC) is a valuable creative sector organisation supporting the literary community in Hobart and Tasmania. The TWC is currently under significant financial pressure and is seeking assistance to continue its operations.

# 2. Report Summary

- 2.1. The TWC is facing closure if sufficient interim funding is not generated to maintain its operations over the next 18 months. It is understood that the difficulties facing the TWC, which have been reported in the media, are largely due to a shortfall in government funding.
- 2.2. One of the TWC's key operating costs is rental at a cost of \$11,000 per annum, the organisation is currently a tenant of the Salamanca Arts Centre.
- 2.3. The TWC held their Annual General Meeting on 4 May 2018 where a new board were selected and it was confirmed that the Centre would continue operating with new funding being sought.
  - 2.3.1. The members of the new TWC Board are as follows: Sue Kennedy – Chair; Kate Eagles – Secretary; Cary Lenehan; Bethany Nader; Robyn Friend; and Terry Whitebeach. The Treasurer role is still being finalised.
- 2.4. In order to reduce expenditure, the TWC has requested that the City of Hobart provide access to vacant office space on the fourth floor of the Hobart Council Centre, at no cost to TWC for a 12 month period. This request is detailed in the email dated 30 April 2018, shown as **Attachment A** to this report. The area proposed for lease is shown as Lot One in **Attachment B**.

2.5. This request has been assessed in accordance with the Council policy 'Leases to Not for Profit Organisations (NFPO)', which provides that those organisations eligible for a rental subsidy be charged a nominal rent of \$50.00 per annum.

# 3. Recommendation

That:

- 1. The Tasmanian Writers' Centre be granted a twelve (12) month lease at a nominal rent for office space on the fourth floor of the Hobart Council Centre.
- 2. The General Manager be authorised to finalise the terms and conditions of the lease with the Tasmanian Writers' Centre and to execute the agreement on the Council's behalf.
- 3. The lease be recorded in the City's Annual Report in accordance with its policy on 'Leases to Not for Profit Organisations'.

# 4. Background

- 4.1. The TWC was incorporated in 1997 and is a member-based not-forprofit organisation. Over its 21 year history the TWC has provided workshops and seminars, employment opportunities, manuscript assessment services, readings and events.
- 4.2. The TWC has hosted a variety of residency programs, and has an ongoing exchange program with Prince Edward Island, Canada with visiting writers staying at the Kelly Street Writers' Cottage in Battery Point.
- 4.3. The TWC has also staged the biennial Tasmanian Writers and Readers Festival, the 2017 festival saw the staging of the inaugural Emerging Tasmanian Aboriginal Writers' Award.
- 4.4. The TWC participates in the National Writers Centre Network, bringing Tasmanian writers before audiences in other states, as well as bringing interstate writers to Tasmania to present workshops and masterclasses.
- 4.5. A key initiative of the TWC is the Young Writers in the City program, which was first staged in Hobart, with support from the City of Hobart. This program has since been staged in Launceston, Devonport and Glenorchy.
- 4.6. The full scope of the organisation's recent activity is detailed in the TWC 2017 Annual Report, shown as **Attachment C** to this report.

- 4.7. The TWC recently announced that it faces closure if sufficient interim funding cannot be generated to maintain its operations over the next 18 months.
- 4.8. It is understood that this is largely due an unanticipated shortfall in government funding from Arts Tasmania. The TWC has advised that the quantum of the loss of Arts Tasmania funding was in the order of \$100,000 to \$120,000, and this decision cannot be reviewed. Arts Tasmania did however, provide interim funding of \$40,000 towards the end of 2017, which allowed for the payment of staff and regular operational expenses.
- 4.9. The TWC has further advised however, that this funding was not sufficient to allow for the appointment of a new Director. The TWC has interviewed and offered a contract to a potential new Director, but this was subject to securing satisfactory funding in the short term. Without the funding level previously secured, it is unlikely the TWC will be in a position to appoint a Director before the end of 2018.
- 4.10. Given this situation, the TWC has advised that the Board is very committed to developing partnerships to establish a more viable financial base for the organisation. This includes the establishment of a 'Go Fund Me' page which seeks to raise funds from the community.
- 4.11. One of the organisation's key operating costs is rental. The organisation is currently a tenant of the Salamanca Arts Centre. It is understood that the current rent paid by TWC to the Salamanca Arts Centre is approximately \$11,000 per annum.
  - 4.11.1. It is understood that the Salamanca Arts Centre, like the TWC, was also unsuccessful in its application to Arts Tasmania for ongoing funding. The loss of the TWC as a tenant will further reduce the Salamanca Arts Centre's revenue.
  - 4.11.2. Approval of a lease to the TWC at a nominal rent may also encourage other creative sector organisations to seek the provision of office space at a subsidised rent in Council properties.
- 4.12. In order to reduce expenditure, the TWC has requested that the City of Hobart provide access to vacant office space on the fourth floor of the Hobart Council Centre of around 47 square metres, at no cost for a 12 month period.
- 4.13. A commercial lease for part of the fourth floor commenced in November 2017. However there are still some smaller office spaces available and it is considered that office space on the fourth floor can be made available in the short term on a 12 month basis. The TWC is aware that should a suitable paying tenant be secured for the office space, it would be required to vacate.

- 4.14. The TWC is a member based organisation which relies on funding from government funding. The request from the TWC for office space at no cost can be considered on the basis that it is a not for profit organisation.
- 4.15. The Council approved an amended 'Leases to Not for Profit Organisations (NFPO)' at its meeting on 7 March 2016. The policy details a number of requirements to be considered when assessing lease requests to NFPOs and provides that a nominal annual rent of \$50 be charged.
- 4.16. The request from the TWC for office space at no cost has been assessed against the criteria in the policy and comments relating to the lease are provided at **Attachment D** to this report.
- 4.17. The proposed office space to be leased to the TWC is 47 square metres. The commercial rent for the office space based the 2016 valuation is between \$160 and \$200 per metre. Taking into account electricity use this would equate to \$8,320 and \$10,400 per annum. If approved by the Council, the TWC would be responsible for telecommunications charges and all other applicable outgoings.

# **Other Council Support**

4.18. The City of Hobart has provided a number of grants to the TWC, including past support for the TWC Young Writers in the City program. Recent City of Hobart grant allocations include:

4.19. It is open for the TWC to apply for funding through the August 2018 round of the City of Hobart's grant program, but before doing so the above grants would need to be acquitted. However, applications would need to be project-specific costs rather than operational, such as subsidised office rental, which are not eligible for City of Hobart funding under the current grant guidelines.

# 5. Proposal and Implementation

- 5.1. Given the importance of the TWC to the Hobart cultural sector, and the Hobart and Tasmanian community more broadly, it is proposed that the Council provide a currently vacant office space on the fourth floor of the Hobart Council Centre, to TWC for a 12 month period, at a nominal cost.
- 5.2. If approved the lease will be recorded in the City's Annual Report in accordance with its policy on 'Leases to Not for Profit Organisations'.

# 6. Strategic Planning and Policy Considerations

6.1. This proposal supports the *Capital City Strategic Plan 2015-2025*, Goal 1 - Economic Development, Vibrancy and Culture, "City growth vibrancy and culture comes when everyone participates in city life".

Strategic Objective 1.5 - Cultural and creative activities build community wellbeing and economic viability.

"1.5.1 - Implement the Council's Creative Hobart Strategy."

Strategic Objective 4.2 - City facilities, infrastructure and open spaces support healthy lifestyles.

"4.2.2 - Support effective utilisation of city facilities, infrastructure and open space."

# 7. Financial Implications

- 7.1. Funding Source and Impact on Current Year Operating Result
  - 7.1.1. There is no financial cost associated with this matter. Should the Council resolve to grant a lease at a nominal rent, it would represent income foregone.
  - 7.1.2. Whilst granting a lease with nominal rent would represent income foregone, it is not considered that this would have a material impact on the current year's operating result given the likely quantum involved.
- 7.2. Impact on Future Years' Financial Result
  - 7.2.1. It is not considered that this would have a material impact on the future years' operating result given the likely quantum involved.
- 7.3. Asset Related Implications
  - 7.3.1. The fourth floor of the Hobart Council Centre will be predominantly tenanted by the commercial tenant.

# 8. Legal, Risk and Legislative Considerations

8.1. If approved the General Manager be authorised to finalise the terms and condition of the lease with the Tasmanian Writers' Centre and to execute the agreement on the Council's behalf.

# 9. Community and Stakeholder Engagement

9.1. The Manager Legal and Governance, the Cultural Programs Coordinator and the TWC have been consulted in the preparation of this report.

# 10. Delegation

10.1. This matter is delegated to the Council.

I am writing to you on behalf of the Tasmanian Writers Centre to seek your City of Hobart's assistance during our current time of funding crisis. As you may be aware, an unexpected funding shortfall has left the TWC in the position where we have been forced to consider a number of options to reduce our expenditures in the short to medium term.

One of our major expenses is rent, which we currently pay to the Salamanca Arts Centre to maintain our office in their premises. I am writing to you to ask Council to consider providing us with free office space for the next twelve months, which should allow the Centre sufficient time to become more financially stable. Ideally, such a space would allow room for two to three casual employees and a Director, allow for meetings with members, and possibly space for us to set up our library of Tasmanian literature and writing resources.

On Friday 27<sup>th</sup> April, Kimbra Parker was kind enough to give me a tour of the currently untenanted office spaces on the 4<sup>th</sup> and 5<sup>th</sup> floors of the Hobart Council Centre. I believe we may have identified a space on the 4<sup>th</sup> floor that would be of sufficient size to house the Centre for the time being. Would you please consider providing this space to us gratis for the next twelve months?


The Tasmanian Writers Centre understands that should a suitably qualified paying tenant put an offer in on the space during this period, that we would be required to vacate.

I'm told that last week, Alderman Sexton made an aldermanic request for council to find a way to help support the Tasmanian Writers Centre in our current difficult circumstances. If you were able to shelter our staff, office equipment and library in the short term, it would be greatly appreciated. As an organization with more than 20 years of service to the Tasmanian writing and reading community, we are committed to reviving the Centre, so that we can continue to initiate and support local literature and literacy initiatives. For your interest, I've attached a copy of our latest annual report, detailing some of the activities undertaken over the last financial year.

#### FROM THE CHAIR

Our previous Chair, Young Dawkins, left the position at the start of 2017, and the position was vacant between January and September of 2017, with Caroline Dean acting in the position for that period. In September, The Director invited me to take on the role, and I attended my first meeting that month (although overseas commitments meant that I was not fully into the role until November). I came into the role at a very busy time – as might be expected given that 2017 was a festival year with the festival itself taking place very soon after I took on the role of Chair. Although I have been involved with the centre, and with the festival, previously, it was especially exhilarating to be drawn into the activities of the Centre at such an important time.

The Festival was itself a great success, as always, and we were very pleased to have A. C. Grayling as one of our headline presenters with the Theatre Royal event that marked the start of proceedings, proving extremely popular. There is a fuller account of the festival, as well as of the range of the Centre's activities over the entire year, elsewhere in this report.

September was an exciting time for the centre, but it was a time that brought some difficult news as well. The centre has always been heavily dependent on funding from bodies like Arts Tasmania and it was with great concern that we received the news that we had been unsuccessful in our application for Arts Tasmania funding for 2018. It is clear that Arts Tasmania has no wish for the Centre to close, but the message is also very clear that, in spite of the Centre's continuing success over many years, there is a desire for the Centre to renew and reorient itself. The Board took up the challenge that this presented, and together with the Director, we began looking at ways in which we might develop in new directions and in a way that would provide greater financial stability in the future. This was not an easy process to take on.

Chris left as Director at the end of 2017, after almost ten years in the role, her departure marking the end of a long and successful era for the Centre. Circumstances change, however, and the Centre has had no choice but to try to adapt to those circumstances. The end of 2017 saw the Centre looking to a search for a new Director as well as to a new framework of operation that would be less financially uncertain. The ending to that story is not one that belongs to 2017, however, and it is a story whose resolution is still unfolding at the time of

this report. I would like to give my thanks as Chair to Chris Gallagher, for all her work over the years, and for inviting me onto the Board as Chair, to the centre's staff, whose commitment to the centre goes well beyond anything that might ordinarily be expected, to the Board, for making me welcome, and for working so hard to meet the challenges that emerged last year, and to the Centre's membership on whom the real future of the Centre's heavily depends. Let's hope 2018 proves to be a year where the centre is indeed able successfully to renew itself and to forge an even brighter future for the next decade.

#### FROM THE DIRECTOR

2017 marks the last year of my time with the TWC. It was a year of surprises, as well as lots of new programs of which our team can be extremely proud. It was a year for the biennial Tasmanian Writers and Readers Festival (TWRF 2017), which always means extra work for the team; and everyone rose to the occasion brilliantly.

It was also the first year we partnered with the Sydney Writers' Festival (SWF) and the State Cinema to stream in the Sydney festival over a full weekend in May. It went well, with over 200 attendees and a small profit for both organisations. On the back of the Sydney Writers' Festival we hosted SWF guest Caroline Brothers, who presented an event called Milestones at the Moonah Arts Centre in June.

Our Twitch program continued to provide state-wide opportunities through the Young Writers residencies in Devonport, Glenorchy and Cygnet. These writing residencies were introduced through local councils and businesses, and they have led to many new partnerships and ongoing programs. A highlight for Devonport was the double trip on the Spirit of Tasmania in January. A partnership with IMAS has extended the residency to writers working with scientists. Online publication of residents' work, readings, and the beautiful posters produced together with the Moonah Arts Centre have all given the programs plenty of profile.

One of the highlights for the year was the successfully funded Emerging Tasmanian Aboriginal Writers Award. Judges included Julie Gough, Gillian Mundy and Bruce Pascoe. The inaugural winner was Adam Thomson, and he and the runners up all celebrated at the Theatre Royal on the opening night of the Festival.

Partnerships with the Glenorchy Art and Sculpture Park (GASP) and Tasmania Parks & Wildlife saw the TWRF program broadening into many new communities, with a multicultural dinner at GASP on the Saturday night, and a trip to Mount Field with Dewayne Everett Smith and Sam Cuff. There was snow on the ground at Mount Field, and it was the highlight for the many Festival guests who attended.

The TWRF has grown incredibly over the two seasons we have held it at Hadley's Orient Hotel. The 2017 Pestival saw the introduction of a children's program and attracted international guests including AC Grayling and Bradley Trevor Greive. Our writers also included Ryan O'Neill, who has gone on to win the Prime Minister's Prize for Fiction; Aurealis Winners Lois Murphy and Tansy Rayner Roberts; and the Charlie Perkins Fellowship winner for 2018, Mireille Juchau. Around 100 writers participated in the program this year (50% increase on the previous Festival) and ticket sales reached just under \$50,000 (increased from \$32,000 in 2015). The Festival team and volunteers this year were nothing short of brilliant.

We welcomed Prince Edward Island writer, Orysia Dawydiak in October, and she was warmly acknowledged by many from our writing community. Orysia gave a workshop, and a reading of her poetry and acclaimed children's fiction at Seasonal Poets.

Marion Stoneman managed the professional development program in 2017, with a focus on nonfiction. Workshops were largely held at Moonah Arts Centre and were all well attended and appreciated.

With all this activity and the newly promised two-year funding from the Australia Council, it was a huge shock to hear, just four weeks before the Festival, that our funding from Arts Tasmania would cease for 2018 despite the high score for the application and plan in the previous year's funding rounds. There was no warning that this was a possibility. Arts Tasmania secured some emergency funding for the TWC in October 2017, with agreement for further discussions to continue.

It is with great sadness that I say goodbye. I have so enjoyed my time with the Centre and made many close friends and professional relationships. I know I carry many of those friendships with me as I move into another phase. I am so grateful for the dedicated team who have worked alongside me every step of the way. I am particularly grateful to Marion Stoneman and the many past Board members who have supported the Centre's growth over almost ten years.

I wish you all the very best of success in whatever writing endeavours you choose and hope the Writers Centre has helped to bring some of your dreams to fruition

#### TASMANIAN WRITERS & READERS FESTIVAL 2017 (TWRF17)

From the 14th to 17th September the Centre ran the 2017 Tasmanian Writers and Readers Festival. Hosted by Hadley's Orient Hotel and brought to life by our Festival Director, Chris Gallagher, along with a dedicated team of staff and volunteers, the event was a resounding success.

Themed around 'Other Worlds In Worlds', the TWRF17 featured a huge range of award-winning local, national and international writers, including Heather Rose, Alec Patric, A. C. Grayling, Clementine Ford, Ryan O'Neill, Bradley Trevor Greive and many more. Masterclasses, panels, keynote speeches and in-conversation events were held across three days, while Fullers ran a pop-up bookshop within Hadley's.

Three special events took place at other venues:

- The Festival Opening Gala event packed out the Theatre Royal. The announcement of the winner of the inaugural Emerging Tasmanian Aboriginal Writers Award (awarded to Adam Thompson) followed a spectacular pulingina-tu milaythina (Welcome to Country) by Nala Mansell. The Challenge of Freedom, with internationally renowned philosopher A. C. Grayling, Heather Rose and Prof Jeff Malpas presented the Festival's opening address.
- On Saturday evening we partnered with GASP (Glenorchy Art & Sculpture Park) to present a multicultural dinner, discussion, performance and projection art journey. The discussion was led by artist Sasha Huber, puralia meenamatta (Jim Bverett) and author and activist Arnold Zable.
- On the Monday following the Festival we partnered with Tasmania Parks & Wildlife Service to offer an excursion to Mt Field National Park to give interstate and international festival guests an opportunity to engage with Tasmania's unique environment. Led by Dewayne Everett-Smith and Sam Cuff.

For the first time we included a children's program in the Festival: the Book Nook (coordinated by Soncha Iacono) featured free readings by Tasmanian children's authors; and two special sessions for children on Sunday morning were presented by Christina Booth and Bradley Trevor Greive with Nicole Gill.

The ABC local radio and Radio National were also Festival partners, and broadcast from the Festival for the popular Meet the Writers session with Helen Shield, Richard Fidler in Conversations, and a fun event The Best Bad Book with Melanie Tait. The festival was a financial success, building on the foundations laid by the 2015 event. More people attended than ever before, and the Centre received fantastic feedback from many guests, writers and attendees. See 'At A Glance' for the Festival in figures.

#### OTHER EVENTS

#### SYDNEY WRITERS FESTIVAL LIVE&LOCAL – AT THE STATE CINEMA

For the first time, the TWC with the State Cinema joined venues around the country to live-stream sessions direct from the Sydney Writers Festival from 26 to 28th May. 19 sessions from the Roslyn Packer Theatre were live-streamed into the State Cinema's Screening Room over three days. The State arranged ticketing, passing on a percentage of takings to the TWC. Audience numbers were fairly small, but all enjoyed the offerings. Attendance ranged from 1 to 30 over the three days (total of 204 tickets sold).

# MILESTONES – CAROLINE BROTHERS IN CONVERSATION

In partnership with Bloomsbury we presented an in-conversation event with author Caroline Brothers, to discuss her book The Memory Stones. Caroline was interviewed by local author James Dryburgh, on stage at the Moonah Arts Centre's Perform space in May. The Memory Stones is a fictionalised account of the disappearances during Argentina's military coup, based on extensive research and interviews she conducted. Fullers were in attendance as booksellers.

# READINGS FROM YOUNG WRITERS IN THE CITY OF GLENORCHY

During June, following their residencies, six young writers presented readings from their work, and participated in a Q&A with TWC board member Robyn Mundy at the Moonah Arts Centre's Perform space. More about the residency in the Twitch section below.

# EMERGING TASMANIAN ABORIGINAL WRITERS AWARD

The Tasmanian Writers Centre was proud to offer the inaugural Emerging Tasmanian Aboriginal Writers Award as part of the 2017 Tasmanian Writers & Readers Festival and Hidden Stories program. Entrants' work addressed the theme 'Reflections on being Aboriginal in Tasmania today', and entries were judged by a panel of three. The winner, Adam Thompson, was announced at the opening event of the TWRF17, and was awarded a cash prize of \$1200 as well as membership to the TWC and a voucher for Local Pizza. Adam read from his work, and along with runners up and other guests appeared in conversation with Tasmanian elder puralia meenamatta (Jim Everett) during the Festival at the Hidden Stories session.

#### PARKS PERSPECTIVES

The 'Get Outside' program, a partnership with Tasmania Parks & Wildlife Service and Wildcare Inc, explores the way different cultures respond to being in nature. TWC engaged writer Gina Mercer to participate in the project, and she spent a weekend on Maria Island with a group of recently arrived refugees and migrants, encouraging and mentoring them to put their experiences into words. With 'Get Outside' participants Gina and Sam Cuff, Education Ranger, also presented a TWRF17 session, Landscapes Clost to Home.

#### PRINCE EDWARD ISLAND EXCHANGE RESIDENCY

This exchange program has been supported by the Universities of Tasmania and Prince Edward Island (Canada) for writers from these islands on alternate years since 2006. In 2017 Canadian writer Orysia Dawydiak travelled to Tasmania for a three-week residency during October. Orysia presented a reading at the Spring Seasonal Poets event and a workshop, Writing About Animals.

#### PEN LETTER WRITING DAY

In December the TWC hosted a PEN International letter writing day in partnership with PEN Melbourne, who have an active program of letter writing, events and publicity designed to increase international pressure on governments that persecute writers for peacefully exercising their rights to freedom of expression. Many members dropped in to the TWC office on 6th December to write letters, cards and emails to detained writers or the families of writers who have disappeared.

#### SEASONAL POETS

We were thrilled to support a new series of poetry readings curated by poets Anne Collins and Gina Mercer, presenting readings by three poets each season (featuring twelve local and visiting poets during the year). The readings took place in the Front Gallery at Hadley's on 20th February, 22nd May, 24th July and 23rd October, with an audience of 40 or more at each event.

#### END OF YEAR GATHERING

We partnered with the Australian Society of Authors (ASA) to finish the year with a social evening for members of both organisations. Tasmanian ASA representative Christina Booth spoke briefly, readings were presented by two of our Twitch residents, Suzi Claffin and Molly Maidment, and prizes were drawn for spathe November subscriberthon.

#### SERVICES & SUPPORT

#### WRITERS' TOOLBOX – INSIGHT INTO THE PUBLISHING INDUSTRY

ABR Information Session: Editor Peter Rose spoke to members about publishing with ABR, including guidelines on what ABR publish and how to submit. A short workshop series, The Business of Self Publishing with presenter Kylie Dunn, was also offered as part of the workshop program (see above) During the TWRF17 we hosted publishers including Barry Scott from Transit Lounge, and Lucinda Sharp from Porty South Publishing, as well as offering a halfday intensive Masterclass on Getting Published with best-selling author Bradley Trevor Greive.

#### NEWSLETTERS

This Writing Month and Writas are the Centre's fortnightly e-newsletters sharing current news, events, awards and opportunities with our members and networks. In 2017 we also sent Festival newsletters to a wider network during the lead-up to the event.

Our Writas newsletters continue our work to encourage and support high standard submissions to contemporary journals such as The Lifted Brow, Seizure Magazine, and Kill Your Darlings, as well as Island and The Griffith Review and The Emerging Writers' Festival. Submission to journals, prizes and other opportunities can be invaluable for career development. The TWC also supports all Tasmanian writers by publicising book launches and other writing-related events in This Writing Month. The newsletters benefit Tasmanian writers by providing access to information and opportunities, as well as a means to promote their work to a wider audience.

#### MANUSCRIPT DEVELOPMENT SERVICES

The TWC manages services including consultations, manuscript assessments and mentorships. These services provide guidance to writers at all stages of their career, as well as employing professional published authors to provide these services. During 2017 the TWC facilitated 11 manuscript assessments and 2 new mentorships (as well as the continuation of 4 Erica Bell Mentorships).

#### TWC LIBRARY

The TWC library collection holds over 1800 books as well as journals and reference works. Members are encouraged to donate copies of their work to the collection, and publishers often provide copies of works by local authors and Festival guests. As well as growing the library, this gives Centre staff access to members' work, enabling them to promote and connect writers with other opportunities. Members can borrow items for three weeks.

Our library and reading lounge offered space for members to read, write and meet. During the lead-up to the Festival, this space became our Festival office, and unfortunately, due to the reduction in available funding this space was relinquished soon after the Festival, and the library collection was relocated into the TWC office.

#### REGIONAL SERVICES AND SUPPORT

In 2017 the TWC was able to support writers in regional areas with a number of initiatives including two Twitch Young Writers in the City projects in Glenorchy and the Huon Valley (see below). Both these YWIC residencies culminated in public readings at the TWRF17 in September, and the Cygnet Folk Festival scheduled for January 2018. In October the TWC also supported the Tasmanian Poetry Festival in Launceston.

#### WRITE ACCESS

A grant from Write Access enabled the Tasmanian Writers and Readers Festival (TWRF) to engage a consultant to advise on accessibility, as well as work with writers to build audience participation and diversify content.

# DIGITAL MEDIA

Twitch provides consulting, support and programming | DIGITAL MEDIA for young and emerging writers. In 2017 the Twitch program was coordinated by Stephanie Eslake, followed by Cassandra Wunsch.

#### TAROONA SCHOOLS PROGRAM

Four young writers who had previously taken part in the Young Writers in the City program were invited to lead two workshops each at Taroona High School for an audience of Year 7 students who had an interest in English and writing. Michael Blake, Vivien Cutbush, Hannah Warwarek and Cassandra Wunsch held workshops on diverse topics including 'zines, character development, writing opportunities in Hobart, and how to get the most out of reading the greats as a writer.

#### YOUNG WRITERS IN IMAS

Jessica Cockerill and Suzli Claffin took up residencies at the Institute of Marine and Antarctic Science this year. Over the course of a month, each spent more than 20 hours partnered with a resident scientist to produce a new essay. Those essays are available on our website. The project, which was funded by Inspiring Australia, will run a second iteration in 2018

#### YOUNG WRITERS IN THE HUON VALLEY

Lily Stojcevski and Molly Maidment (our youngest ever participant at 15) spent 20 hours each on location in Cygnet and the Red Velvet lounge. Each wrote a piece inspired by their surroundings which, while steeped in the same locale, were profoundly different. Both of these pieces, one of which can be read both forwards and backwards, are available on the TWC website.

#### YOUNG WRITERS IN THE CITY

Since it began in 2015, Young Writers in the City has seen dozens of writers supported to produce news works and publish them on our platform. In 2017 we partnered with the City of Glenorchy to give six writers the opportunity to create something new. Elissa Evans, Kate Dewar, Laura Hilton, Lily Newell, Vivienne Cutbush and Zara Gudnason wrote in diverse places around the Glenorchy municipality. These partner locations included the Migrant Resource Centre, MONA, GASP, and Northgate shopping centre, to name a few.




Staff turnover in 2017 has meant that our digital presence had to be streamlined and carefully managed. Arianne James has continued to provide Q&As and Recommended Reads throughout the year, which have been very popular.

The website averages between 1200 and 1400 hits per day with the majority of them looking for either program information, or our curated content (local writers' work that we host, Q&A etc).

Our Events feature on the website has drawn interest not only from the public but from other arts organisations wishing to have their events shared through our networks. This has provided an opportunity to engage more fully with our audience, offering them a wider variety of opportunities. It has also built our relationships with industry stakeholders, who feel positively about our ability to advertise their events.

The overall social media strategy has by necessity been one of streamlining posting and focusing on types of content that our statistical data tells us the audience responds to. For this reason we have focused on consistency of posting. During prime months or when staff hours allow, posting is at 8am and 5pm Monday through Friday, with incidental posts appearing from events as they happen. For the first time we also experimented with live-streaming video content from and in the lead-up to the Festival. Josie Chapman (Communications Officer) proved that this was a well received and highly engaging content category and one we will be looking at utilising at future events.




