## MEMORANDUM: ECONOMIC DEVELOPMENT & COMMUNICATIONS COMMITTEE

## Invitation to Visit Friendship City of Xi'an

This memorandum relates to a potential international delegation to visit Hobart's friendship cities of Xi'an and Fuzhou in China in September 2019. A number of events and circumstances have coincided in both Xi'an and Fuzhou which will create strong outcomes for Hobart should representatives of the city attend. These include relationship building, information sharing, increased knowledge on the 'One Belt One Road' initiative, supporting a Hobart based sports club and discussing the future of the Xi'an relationship.

#### Invitation from Xi'an

The Lord Mayor on 08 July 2019 received an invitation to attend the 2019 Euro-Asia Economic Forum from 9-12 September **(Attachment A)** in Xi'an. Hobart has been invited to attend the economic forum because of its status as a friendship city to Xi'an. Attendance at the forum constitutes a friendship city activity. The forum is a platform for discussion of President Xi Jinping's economic focus – 'One Belt One Road' which he launched in 2013.

#### One Belt One Road (OBOR)

According to the <u>Parliament of Australia</u> OBOR is a 'Chinese economic and strategic agenda by which the two ends of Eurasia, as well as Africa and Oceania are being more closely tied along two routes – one overland and one maritime.' Hobart has a strong strategic position with respect to the overland and maritime silk roads as Xi'an is the start of the former and Fuzhou the start of the latter. Both of these Chinese cities are friendship cities of Hobart.

#### Economic Forum 2017

Alderman Thomas as part of his professional development program and one officer attended the forum and discussions in 2017. This forum was established in 2005 and has been staged every two years since. In 2017 1,000 people attended from around the world, with the most senior being one of only four Vice Premiers of China.

#### Discussions with other international cities

As an extension of the forum, a roundtable discussion was held for international partners. Alderman Thomas represented Hobart at this roundtable and was able to share information about the city to an international audience including other friendship cities of Xi'an - Kansas City (USA), Kragujevac (Serbia), Pompeii (Italy), Umea (Sweden), Istanbul (Turkey), Kagawa-Ken (Japan) and San Jose (Uruguay).

Attending Xi'an at this time provided an opportunity to forge face to face relationships with Xi'an officers and have a number of discussions with some of Xi'an's other friendship cities. Discussions included what projects other cities were working on with Xi'an, how often they visited each other / were in contact and how they measure the value of their relationships. Contacts made in 2017 are still proving useful to the City of Hobart in the international relations space.

Should a delegation visit Xi'an in September, this would be valuable in terms of learning more about Xi'an, the OBOR economic strategy and Xi'an's activities in other international relationships. This would be in line with the City's International Relations Action Plan (IRAP) stating that visits to friendship cities should be conducted every two years. Except for the forum in 2017, the last visit to Xi'an by a delegation from Hobart was 2015 to sign the friendship agreement.

#### Friendship City Discussions with Xi'an

It is also proposed that representatives of Hobart take this opportunity to travel to Xi'an to discuss the future of the relationship. The friendship city agreement was signed on 29 March 2015. Wording in the agreement states that it will be valid for five years and upon its expiration it will be reviewed by both sides. It is proposed that the City initiates discussions about the future of the relationship ahead of March 2020.

The Hobart – Xi'an connection has significant potential. Xi'an has a 3,000 year history, is the cultural capital of China and has a number of highly ranked educational institutions including the Xi'an University of Science and Technology and the Xi'an Conservatorium of Music which are connected to UTAS. It is felt however that this potential has not been reached and that officer to officer contact between the two cities and concrete projects beyond school and university links have been limited. Should the relationship be extended beyond 2020, more activity would be necessary.

#### Fuzhou

It is prudent when visiting one friendship city in China to visit the other as this saves the economic and environmental cost of long-haul travel. By chance, on 13 and 14 September Fuzhou is staging an international youth soccer tournament for its friendship cities. At this stage a team from Brazil, Japan, Hobart and Fuzhou are competing, with Hobart represented by a boys' under 15 team from South Hobart Football Club. Attendance by elected members from the City would increase the profile of the tournament and be a strong indication to Fuzhou of the value Hobart places on the relationship (which to date has been very active). It is likely that elected members would have an opportunity to visit key sites in the city and meet with the Fuzhou Government to discuss the relationship.

#### Costs

Elected members will be aware of section G of Council's Elected Member Development and Support Policy that states:

> "Individual elected members may elect to participate in Council funded and approved international city relationship delegations, up to a maximum budget allocation of \$6,000, during their four-year term of office."

Should elected members seek nomination for this visit to Xi'an and Fuzhou, all costs associated with the visit will be deducted from their individual allocation of \$6,000.

Accommodation is budgeted at \$300 per person per night. It is estimated that the visit would be for 8 nights. Total accommodation = \$2,400.

A flight to Xi'an, an internal flight to Fuzhou and a return from Fuzhou economy class departing around Saturday 7 September and returning on Sunday 15 September will cost approximately \$2,000.

Other costs include elected member allowance 40 p/d = 40 x 8 = 320. Meal budget 25 p/d = 25 x 8 = 200. Transport = 100. Visa = 235.

Total estimated cost of the visit per elected member is **\$5,255** and would be funded from the International Relationships line item within the Elected Member Allowance and Expense function of the 2019-20 Annual Plan. A total of \$36,000 is available in the budget.

#### RECOMMENDATION

- *That:* 1. That the estimated costs of \$5,255 per elected member to travel to Xi'an and Fuzhou be noted.
  - 2. Council seeks nominations for elected members to travel to Hobart's friendship cities of Xi'an and Fuzhou in September 2019.
  - 3. The General Manager and /or his nominee also attend.
