That pursuant to the *Hobart Interim Planning Scheme 2015*, the Council refuse the application for partial demolition at 34 Proctors Road, Dynnyrne 7005 for the following reason:

1. The proposal does not meet the acceptable solution or the performance criterion with respect to clause E13.8.1 A1 and P1 of the Hobart Interim

Planning Scheme 2015 because a chimney would be demolished and that chimney is significant and makes a contribution to the historic cultural heritage significance of the precinct. The applicant has not articulated environmental, social economic or safety reasons of greater values to the community than the chimney. A prudent and feasible alternative would have been to retain the chimney.
