## MEMORANDUM: COMMUNITY, CULTURE AND EVENTS COMMITTEE

### Overview - City Events and Activations

#### Introduction

The purpose of the report is to provide Elected Members with an update on the 2021 festive season activation program, the status of Hobart events since Tasmanian borders opened on 15 December and the activation planning for the remainder of this financial year.

#### 2021 Festive Season

##### *Santa is Coming to town!*

As a replacement for the Hobart Christmas Pageant, a bespoke multi-week and multi-site event, *Santa is coming to Town!* was held. Each Saturday from 13 November 2021 until Christmas Eve an oversized parcel was placed at various locations around Hobart, supported by entertainment at each parcel site from 11 am until 2 pm. In addition, a week-long *Santa is Coming to Town!* activation at Mawson Place was held, kicked-off by Santa's arrival on a jet ski and entertainment. A display of oversized 'toys' created a focus around the Mawson Place Christmas tree.

An outline of this program is included as **Attachment A** to this memo.

##### *City of Hobart grants*

The City awarded six community Christmas carol grants through the City of Hobart Grants Program. The grants were awarded based on the standard competitive assessment process and approved by the Chief Executive Officer in October. Of these, two were cancelled due to the additional effort required to be compliant with COVID-19 restrictions.

## Revised Summer Activation and Events Program

The effects of COVID-19 on the community and business since the opening of the Tasmanian borders to the rest of Australia on 15 December 2021 and the rapid rise of COVID-19 infections in Tasmania have triggered a rethink the Summer Activation Program that was approved by Council on 9 August 2021.

The revised program includes features of the original program, re-shaped in a way that responds to community concern about COVID-19, that can be delivered outdoors in a Covid-safe way and that spreads activities over five months of continuous, smaller-scale public activations.

The Waterfront Weekend, postponed from January 22 and 23, is included in the updated program and scheduled to be delivered in May. The proposed format lessens the emphasis on the Salamanca Market 50<sup>th</sup> birthday – the market team is considering an activation for later in the year in the lead up to the key 2022 retail and tourism season.

It has been recommended to not proceed with the original Food Truck Palooza proposal, principally due to Covid concerns around unmasked eating and drinking, social distancing in queues as well as the ability of the team to design an attractive event proposition to wrap around the trucks. Food vans are, however, a key stakeholder and will be integrated into the program at every opportunity, for example, the drive-in cinema event.

A focus for the revised program is the ability to engage artists, arts workers and event suppliers at a time when there is continuing uncertainty for the creative industries.

The revised program has the approval of the Chief Executive Officer in line with Council resolution of 8 August 2021 that delegated this authority to the Chief Executive Officer.

### Youth Programs City Activations

In addition to the program that is being prepared by the activations and events team (Activation Programs and Tourism), the youth programs team (Community and Culture) has developed a series of activities and performances to be held in public spaces in the City over January and early February. These activities enliven and add vibrancy to the City whilst providing young people with the opportunity to perform in public spaces.

The activities are primarily focussed in Collins Court, Wellington Court and the Elizabeth Street Mall. There are musical performances and small dance group performances as part of a *Bustin out a Busker* program along with craft and creative projects. The majority of the performances are being held over the lunchtime period with some activities, such as the *Hobart Hope Tree* in Collins Court continuing over several days.

## **MEMORANDUM: COMMUNITY, CULTURE AND EVENTS COMMITTEE**

### **Applications Approved Under the Delegated Authority of the Chief Executive Officer for August 2021 Biannual Grant Round.**

Elected Members are advised that the attached list of 29 activities have been awarded a grant from the City of Hobart as part of the August 2021 biannual grant round. This grant round included the Community, Creative Hobart Small and Medium, Event Medium and Local Business for a Better Community grants.

On 1 December 2021, the Chief Executive Officer approved the recommendations provided by the grant assessment panels for the August 2021 biannual grant round. The authority to approve these recommendations was delegated to the Chief Executive Officer at the Council meeting held on 21 January 2019.

There were 60 applications eligible for assessment, the 29 activities in the five grant categories that are approved for full or partial funding and have a total grant allocation of \$238,332.

The 29 activities recommended for funding expected to have a total expenditure of \$1,775,482. The City of Hobart grants contribute 13 per cent of this total project expenditure for the activities. This equates to a benefit of \$7.45 generated for every dollar contributed by the City.

The approved grant recipients for the August round will engage 623 volunteers and 258 paid personnel.

There continues to be new interest in the program. Of the approved applications 11 will receive support from the City of Hobart for the first time (representing 38 per cent of the approved applications).

The next biannual grant round for this financial year will be conducted in February 2022.

Section 29 of the *Local Government (Meeting Procedures) Regulations 2015*.  
File Ref: 13-1-10

An Elected Member may ask a question without notice of the Chairman, another Elected Member, the Chief Executive Officer or the Chief Executive Officer's representative, in line with the following procedures:

1. The Chairman will refuse to accept a question without notice if it does not relate to the Terms of Reference of the Council committee at which it is asked.
2. In putting a question without notice, an Elected Member must not:
  - (i) offer an argument or opinion; or
  - (ii) draw any inferences or make any imputations – except so far as may be necessary to explain the question.
3. The Chairman must not permit any debate of a question without notice or its answer.
4. The Chairman, Elected Members, Chief Executive Officer or Chief Executive Officer's representative who is asked a question may decline to answer the question, if in the opinion of the respondent it is considered inappropriate due to its being unclear, insulting or improper.
5. The Chairman may require a question to be put in writing.
6. Where a question without notice is asked and answered at a meeting, both the question and the response will be recorded in the minutes of that meeting.
7. Where a response is not able to be provided at the meeting, the question will be taken on notice and
  - (i) the minutes of the meeting at which the question is asked will record the question and the fact that it has been taken on notice.
  - (ii) a written response will be provided to all Elected Members, at the appropriate time.
  - (iii) upon the answer to the question being circulated to Elected Members, both the question and the answer will be listed on the agenda for the next available ordinary meeting of the committee at which it was asked, where it will be listed for noting purposes only.
